

INTERDISCIPLINARY MANAGEMENT OF ESTHETIC AND RESTORATIVE DILEMMAS

Some of the most challenging esthetic and restorative dilemmas are those that fall into a gray zone between traditional therapies. The complexities of diagnosing these problems, coupled with the lack of optimal treatment options, often lead to inappropriate treatment and disappointing compromises. presentation will focus on an interdisciplinary approach to diagnosing the fundamental components of these complex problems and managing them by combining traditional therapies with new treatment options to ideally address the underlying issues and more predictably achieve success. These new options include surgically facilitated orthodontic therapy (SFOT) utilizing corticotomies and single- or multipletooth osteotomies.

Learning Objectives:

- Solutions to esthetic dilemmas often fall into a "Gray Zone" between the different disciplines
- An interdisciplinary approach is needed to properly diagnose and treatment plan these problems
- Recent advances in orthodontics can assist the interdisciplinary team to more predictably treat these problems

GLOBAL APPROACH TREATMENT PLANNING- FROM IMPLANTS TO AIRWAY TO TM JOINT TO SMILE DESIGN

Summary of Topic: To demonstrate specific Facial and Skeletal characteristics that correlate to Temporomandibular Joint pathologies and the impact on Esthetics, Occlusion and Airway and the impact of these characteristics on treatment outcomes. COULD IT BE AN AIRWAY PROBLEM? THE STORY OF THREE PATIENTS

The hardest beliefs to change are those learned in dental school or residency. The first exposure to a concept seems to stick even when presented with new clinical evidence to the contrary. Dr. Rouse will present a personal journey of airway-induced problems found in three of his patients. All three were missed by the "normal" medical and dental practices and procedures. No one bothered to ask, "Could this be Airway?" Dr Rouse will also present the challenges to changing the mindset of your team members including those in the medical community.

TMD FOR THE GP: WHY ARE YOU CLENCHING AND GRINDING YOUR TEETH? WHAT IS A CLICK?

There seems to be no consensus on what TMD is and more importantly how to treat it. The various TMD specialists all seem to disagree, so that as a non-TMD expert, most doctors come to believe doing the least amount is a prudent approach. This course will help you understand why there was so much confusion and disagreement in the past. You will also learn how you can identify, diagnose and treat specific types of TMD in your practice, that will benefit both your patients and the practice.

You will Learn:

Why so much confusion in the past?

Temporomandibular Disorders are not one disease.

Understanding the different diseases that make up the umbrella term TMD will bring some clarity to the confusion.

- Clenching and Grinding: What it is and what to do about it
- Identifying patients in your practice who grind and clench.
- Grinding is different than clenching. How to identify each type.
- There are three types of grinding patients, two types of clenching patients.
- How to chose the correct night appliance specific for each condition.
- How to treat the three different types of grinding.
- How to stop clenching.
- How to use a simplified occlusal orthotic to identify patients with Occlusal Muscle Disorder.

What is TMJ clicking?

All clicking temporomandibular joints are damaged.

The 5 different types of TMJ damage that can produce a clicking sound.

Most damaged temporomandibular joints do not need treatment.

The clinical implications of "The Click".

How to identify dangerous clicks.

Identifying patients whose condition will be made worse by dental procedures. The disease progression and treatment for the few clicks that need therapy. Introduction into reading MRI and CT scans.

A LOOK AT NEW MATERIALS THROUGH THE LENS OF PROVEN PRINCIPLES

There are proven restorative materials whose preparation requirements, fabrication techniques, and functional predictability are very familiar to dentists and dental laboratory technicians. At the same time there is a barrage of commercially biased information to sort through regarding new materials and technologies. In this presentation we will accomplish an impartial examination of the properties and the evidence associated with these "hot" new materials as well as their different fabrication techniques. Based on our knowledge of proven principles, we will discuss how these restorative alternatives compare with traditional options and what we might predict for these new, and often untested materials.

Participants should understand:

- -what considerations, other than "will it break?", come into play when determining whether a material has the potential for long term success or failure
- -the physical properties for all-ceramic materials with particular emphasis on what most frequently leads to failure
- -a proven, but often ignored, thought process to consider when evaluating restorative materials


